Sl. No.	The school is directed to ensure that:
1	The total number of sections of Bal Vatika shall be restricted to 03 (one sections each in Bal Vatika I, II & III respectively) and total number of sections of the school from class I to X shall be restricted to 10. The optimum number of the students shall be restricted to 40 in each section. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension.
2	The school is not running bal-vatika. Thus, it is required to submit an undertaking on its letterhead that it will run the bal-vatika in the upcoming session within 03 months in the compliance.
3	As per records, the school was granted fresh affiliation upto secondary level with 8100 sq mtrs of land. However, as per compliance school has stated that, its total land area is now 9712 sq mtrs of land. Thus, the school is directed to apply on SARAS Portal for increase of land area from 8100 sq mtrs to 9712 sq mtrs when the portal is open (in upcoming session) and submit an undertaking in this regard on its letterhead duly signed by principal and manager of the school within 03 months and submit the compliance.
4	The school is directed to submit the copy of renewed permanent recognition certificate and society registration certificate / trust deed within 03 months in the compliance.
5	The lift to access upper floors is under construction. Thus, the school is required to install the same as per RPwD Act and Board's Guidelines within 03 months and submit the compliance.
6	Boy's urinals are constructed in the open area, which is not appropriate. Thus, the school is required to cover the said area properly within 03 within 03 months and submit the compliance.
7	The mathematics lab appears to be a make-shift arrangement with insufficient seating facility and equipment. Thus, the school is required to set-up the same as per Board's SoP for math lab within 03 months and submit the compliance.

8	The school is required to upgrade the indoor /outdoor game facilities (with permanent court) as per Board's SoP within 03 months and submit the compliance.
9	The library is under stocked and poorly managed with unsuitable furniture (desks). Thus, the school is required to upgrade the same with more books and sufficient seating arrangement for students and separate reading space for staff within 03 month and submit the compliance.
10	The composite science lab is set-up on the tables it does not have the seating arrangement (wooden stools), gas connection in the workstations and safety features such as fire extinguisher and exhaust fan. The open almirah have been used for storage facility. Further, there is a side slab constructed adjacent to the wall is not appropriate for conducting practical. Thus, the school is required remove the side slab and upgrade the composite science lab as per Board's SoP within 03 months and submit the compliance.
11	The school is required to construct the CwSN toilets separately for boys and girls on each floor with sufficient space for easy movement of the wheelchair as well as handrail on both side of toilet seat (fixed and movable) and proper permanent signage (on the cubicle indicating the floor number) as per norms of RPwD Act and board's guidelines within 03 months and submit the compliance.
12	The school shall conduct training of its teachers with CoE Prayagraj and submit the compliance within 03 months

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The above sanction is subject to fulfillment of following conditions:-

- 1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
- 2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3. The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school is required to renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
